### **Consent for Disclosure of Personal Information** (this "Consent")

I Ken Sam as registered holder of trapline "714T008" and more importantly, vested with Aboriginal Title and Rights for the "Daiya-Mattess Keyoh", hereby consent to the disclosure by the Ministry of Forests, Lands, Natural Resource Operations and Rural Development (the "Ministry"), the Province of British Columbia (BC) and Canada of my Personal Information as follows:

- 1. The Ministry, BC and Canada may disclose my personal information, including the name of my Keyoh, my title as the Keyohwhudachun (Chief), my name, mailing address, phone number, and my email address ("Personal and Aboriginal Title and Rights Information") to all crown ministries and third parties who are required to contact me for the purposes of engagement, consultation and for the provision of accommodation to us on activities that may impact my Aboriginal Title and Rights. This includes any authorizations or licences, or activities issued by the Ministry, BC and Canada (e.g. forest harvesting proposals, mineral tenure, or land tenure proposals, etc.);
- 2. I acknowledge that the Ministry is under no obligation to provide my Personal Information to third parties for the Purposes of Disclosure or for any other purpose.
  - I acknowledge that, beyond this Consent, I will not have the opportunity to preapprove the Ministry disclosing my Personal Information in response to any thirdparty requests for disclosure for the Purposes of Disclosure.
- 3. I agree to waive my rights to, and to release and hold harmless the Ministry from, any and all claims I may have against them by reason of any fact or matter in any way relating to their disclosure of my Personal Information, or otherwise relating to the subject matter of this Consent.

# NOTICE OF ABORIGINAL TITLE for DAIYA-MATTESS KEYOH

We are including a map of our Aboriginal Title territory. This is our ancestral Keyoh territory to which my family are Dakelh people and are vested with both Aboriginal Title and Rights. Our Aboriginal Title vests over the totality of this territory.

As the holder of Aboriginal title to this territory, my family maintain the jurisdiction and decision-making capacity concerning the use of all lands, waters, airspace and resources within this area. Our relationship to our Aboriginal Title territory is vital to who we are as a peoples, and is constitutionally protected under Section 35 of the *Constitution Act*, 1982

The Supreme Court of Canada in Delgamuukw stated that Aboriginal title is an interest in the land itself, and that Crown Title is subject to Aboriginal title. Please be advised that any and all use, or authorizations for use of our territories and resources, requires our full consent.

The Supreme Court in Delgamuukw has stated that there is a requirement on the part of the Crown to give Aboriginal Title a priority, over and above the duty to consult and the requirement that there be compensation for any infringement of title.

Having received this and our other notices of Aboriginal Title and rights to our territory, we trust that you will uphold your legal fiduciary obligations and the honour of the Crown by ensuring that we are meaningfully involved in all applications being considered, and that no land, water or resource development activities are approved without our full consent.




Figure 2 See provincial trapline boundary TR#0714T008 for title map location
